LD 2310 / HP1638

An Act to Make Certain Revisions in the Maine Tax Laws and Appropriations from the General Fund. Presented by Rep. Cashman of Old Town; Co-sponsored by Rep. Mayo of Thomaston, and Sen. Twitchell of Oxford. Taxation Hearing 04-02-86. Majority OTP-ND HP1700 / LD 2393 Accepted by Senate (Minority OTP-ND-NT HP1701 / LD 2394); House - Indefinitely Postponed. Died Between Houses.
