LD 2311 / HP1639

An Act to Authorize a General Fund Bond Issue in the Amount of \$7,700,000 for Various Projects at the University of Maine. Presented by Rep. Roberts of Farmington; Co-sponsored by Sen. Pearson of Penobscot, Rep. Brown of Gorham, and Rep. Lisnik of Presque Isle. Appropriations & Financial Affairs Hearing 05-21-86. Amended by: CC H-753. Enacted, Approved 06-06-86, P & S LAWS, Chapter 139. Approved in Referendum, 11-04-86 (In favor: 227,751; Opposed: 173,527).
