Resolution, Proposing an Amendment to the Constitution of Maine Providing for Filling a Vacancy in the Office of Governor after the Convening of the Legislature and Before the Governor-elect is Inaugurated. Presented by Sen. Violette of Aroostook; Co-sponsored by Sen. Perkins of Hancock, Sen. Clark of Cumberland, and Sen. Gill of Cumberland. State Government Hearing 05-27-86. OTP-AM Accepted 05-28-86. Amended by: CA S-551. House Failed Final Passage; Senate - Finally Passed. Died Between Houses.
