LD 2439 / HP1758

Original Title: An Act to Authorize a General Bond Issue in the Amount of \$15,000,000 for Construction and Renovation of Correctional Facilities. New Title: An Act to Authorize a General Bond Issue in the Amount of \$16,000,000 for Construction and Renovation of Correctional Facilities. Presented by Rep. Nelson of Portland; Co-sponsored by Sen. Gauvreau of Androscoggin, Sen. Gill of Cumberland, and Rep. Manning of Portland. Engrossed Without Reference to Committee. Amended by: HF (Changed Title) H-776, HG H-777. Enacted, Approved 06-11-86, P & S LAWS, Chapter 142. Approved in Referendum, 11-04-86 (In favor: 222,679; Opposed: 180,787).
