AN ACT Regarding the Generation of Electric Power and Highlevel Radioactive Waste. Energy & Natural Resources Hearing 03/25/87. Majority ONTP Accepted 04/14/87 (Minority OTP). Referendum question: "Do you want to let any power plant like Maine Yankee operate after July 4, 1988, if it makes high level nuclear waste?" Question Approved in Referendum and Proposed Law Failed, 11/03/87 (In favor of question: 235,069; Opposed: 162,902).
