LD 86 / HP0083

AN ACT to Divest State Pension Funds from those Businesses or Corporations doing Business in the Republic of South Africa and Namibia. Presented by Rep. Baker of Portland; Co-sponsored by Rep. Webster of Cape Elizabeth, Rep. O'Gara of Westbrook, and Rep. Martin of Eagle Lake. Aging, Retirement & Veterans Hearing 02/04/87. Majority OTP-AM Accepted 05/26/87. (Minority ONTP). Amended by: CA H-163. Enacted, Approved 06/10/87, PUBLIC LAWS, Chapter 247.
