AN ACT to Increase State Revenue Sharing to 7 percent of Sales and Income Tax Receipts. Presented by Rep. Nadeau of Lewiston; Co-sponsored by Rep. Cashman of Old Town, Sen. Emerson of Penobscot, and Rep. Martin of Eagle Lake. Appropriations & Financial Affairs Hearing 03/31/87. Pursuant to Joint Order SP 648, this Bill was Carried Over from a Previous Session.
