AN ACT to Aid in Enforcement of Child Support Payments. Presented by Rep. Duffy of Bangor; Co-sponsored by Rep. Paradis of Augusta, Rep. Vose of Eastport, and Sen. Perkins of Hancock. Judiciary Hearing 03/03/87. Minority OTP-ND (HP0958 / LD 1287) Accepted by House; Majority ONTP Accepted by Senate. House - Insisted on Engrossing; Senate - Insisted on ONTP. Died Between Houses.
