Original Title: AN ACT to Increase the State's Share of Education Costs. New Title: AN ACT to Increase the State Funding of Educational Costs. Presented by Rep. Cashman of Old Town; Co-sponsored by Rep. Martin of Eagle Lake, Rep. Bost of Orono, and Sen. Emerson of Penobscot. Education Hearing 03/31/87. Pursuant to Joint Order SP 648, this Bill was Carried Over from a Previous Session. Majority OTP-AM Accepted 04/14/88 (Minority ONTP). Amended by: SA (Changed Title) S-492, SB/SA S-544. Emergency Enacted, Approved 05/02/88, PUBLIC LAWS, Chapter 848.
