AN ACT to Require Registration of Persons Proposing to Distribute Free Tobacco Products. Presented by Sen. Gauvreau of Androscoggin; Co-sponsored by Rep. Ketover of Portland, Rep. Boutilier of Lewiston, and Sen. Gill of Cumberland. Business Legislation Hearing 03/31/87. In House - Majority ONTP Accepted by House (Minority OTP-AM). In Senate - Indefinitely Postponed.
