LD 602 / SP0221

AN ACT to Include the Term Sexual Orientation in the Maine Human Rights Act. Presented by Sen. Andrews of Cumberland; Co-sponsored by Rep. Connelly, Jr. of Portland, Rep. O'Gara of Westbrook, and Rep. Rydell of Brunswick. Judiciary Hearing 05/11/87. Majority ONTP Accepted by Senate (Minority OTP). House - Indefinitely Postponed.
