AN ACT Enabling Municipalities to Establish Municipal Land Banks Funded by a Local Option Real Estate Transfer Tax. (Reported Pursuant to Private and Special Laws, Chapt. 119 of 1985). Taxation Hearing 04/16/87. Majority ONTP Report; Minority OTP Report. Recommitted to Taxation. Majority ONTP Report Accepted by Senate; Minority OTP-AM Accepted by House. Senate - Adhered to ONTP; House - Insisted on Engrossing as Amended by CA. Died Between Houses.
