AN ACT Concerning Access Fees. Presented by Sen. Pray of Penobscot; Co-sponsored by Rep. Martin of Eagle Lake, Sen. Usher of Cumberland, and Rep. McGowan of Canaan. Taxation Hearing 04/30/87. Pursuant to Joint Order SP 648, this Bill was Carried Over from a Previous Session. Recommitted to Taxation 04/08/88. Majority OTP-AM Accepted 04/18/88 (Minority ONTP). Amended by: CA S-476. Enacted, Approved 04/21/88, PUBLIC LAWS, Chapter 755.
