AN ACT to Amend the Law Relating to Unitary Taxation of Corporations. Presented by Rep. Cashman of Old Town; Cosponsored by Rep. Jackson of Harrison, Rep. Nadeau of Saco, and Sen. Twitchell of Oxford. Taxation Hearing 05/14/87. Pursuant to Joint Order SP 648, this Bill was Carried Over from a Previous Session. Majority OTP-AM Accepted 04/15/88 (Minority ONTP). Amended by: CA H-710, SA/CA S-511. Enacted, Approved 05/02/88, PUBLIC LAWS, Chapter 841.
