History and Final Disposition

LD 1337 / HP0991

AN ACT to Increase Maine's Sales Tax to 6% and to use the Funds Generated to Support the University of Maine System, the Maine Vocational-Technical Institute System and Immediately Increase the State's Share of Education Funding to 65%. Presented by Rep. Nutting of Leeds; Co-sponsored by Rep. Smith of Island Falls, Rep. Thistle of Dover-Foxcroft, and Rep. Joseph of Waterville. Taxation Hearing 05/13/87. Pursuant to Joint Order SP 648, this Bill was Carried Over from a Previous Session. Majority ONTP Accepted 04/19/88 (Minority OTP-AM).
