LD 1370 / HP1017

AN ACT Allowing the Town of Island Falls to Annex Township 4, Range 3 WELS in Aroostook County. Presented by Rep. Smith of Island Falls; Co-sponsored by Rep. Martin of Eagle Lake, and Sen. Pray of Penobscot. State and Local Government Hearing 05/14/87. Pursuant to Joint Order SP 648, this Bill was Carried Over from a Previous Session. Majority OTP-AM Accepted by House; Minority ONTP Accepted by Senate. House - Adhered to Engrossing; Senate - Adhered to ONTP. Died Between Houses.
