AN ACT to Establish a 10% Surtax on Fines to be Dedicated to the Maine Criminal Justice Academy in Lieu of Tuition Paid by Municipalities. Presented by Rep. Vose of Eastport; Co-sponsored by Rep. Gwadosky of Fairfield, and Rep. Jacques of Waterville. Legal Affairs Hearing 05/18/87. Pursuant to Joint Order SP 648, this Bill was Carried Over from a Previous Session. Leave to Withdraw Accepted 01/27/88.
