**History and Final Disposition**

LD 1618 / HP1188

AN ACT to Clarify the Offense of Driving under the Influence of Illegal Drugs. Presented by Rep. Warren of Scarborough; Co-sponsored by Rep. MacBride of Presque Isle, Rep. Lebowitz of Bangor, and Rep. Stevenson of Unity. Judiciary. Ruled in Violation of Joint Rule 24. Pursuant to Joint Order HP 1325, this Bill was Recalled from the Dead Files. Recommitted to Judiciary. Pursuant to Joint Order SP 648, this Bill was Carried Over from a Previous Session. Leave to Withdraw Accepted 01/20/88.

Joint Order, That Bill, "An Act to Clarify the Offense of Driving under the Influence of Illegal Drugs," HP 1188, LD 1618, be recalled from the legislative Files to the House of Representatives. Presented by Rep. Warren of Scarborough. Passed in Concurrence, 06/12/87.
