AN ACT to Authorize Kennebec County to Raise up to \$9,500,000 for Construction and Improvement of Jail Facilities for Kennebec County. Presented by Sen. Bustin of Kennebec; Co-sponsored by Sen. Matthews of Kennebec, Rep. Weymouth of West Gardiner, and Rep. Hickey of Augusta. State and Local Government Hearing 06/15/87. Majority OTPAM Accepted 06/16/87 (Minority ONTP). Enacted, Approved 06/26/87, P & S LAWS, Chapter 56.
