LD 1830 / SP0623

Original Title: An Act to Authorize Androscoggin County to Raise Up to \$8,900,000 to Renovate and Expand Jail Facilities for Androscoggin County. New Title: An Act to Authorize Androscoggin County to Raise Up to \$8,900,000 to Construct a New Jail for Androscoggin County. 2nd New Title: An Act to Authorize Androscoggin County to Raise up to \$8,900,000 to Improve and Construct Jail Facilities for Androscoggin County. Presented by Sen. Gauvreau of Androscoggin; Cosponsored by Rep. Callahan of Mechanic Falls, Rep. Cote of Auburn, and Rep. Stevens of Sabattus. State and Local Government Hearing 06/15/87. Majority OTP-AM Accepted 06/17/87 (Minority ONTP). Amended by: CA (Changed Title) S-228, SB/CA (Changed Title) S-232. Enacted, Approved 06/26/87, P & S LAWS, Chapter 63.
