AN ACT to Prohibit Random or Arbitrary Substance Abuse Testing of Employees.
Presented by Sen. Dutremble of York; Co-sponsored by Sen. Pray of Penobscot, Rep. McHenry of Madawaska, and Rep. Joseph of Waterville. Labor. Engrossed Without Reference. Enacted, Veto Sustained.
