AN ACT Concerning Investment of State Funds in Corporations Doing Business in Northern Ireland. Presented by Sen. Kerry of York; Co-sponsored by Rep. Curran of Westbrook, Rep. Conley of Portland, and Sen. Brannigan of Cumberland. Aging, Retirement & Veterans Hearing 02/11/88. Majority OTP-AM Accepted 03/14/88 (Minority ONTP). Amended by: CA S-323. Enacted, Veto Sustained.
