LD 2191 / SP0845

AN ACT to Make Interim Adjustments in the Certificate of Need Development Account. Presented by Sen. Gill of Cumberland; Co-sponsored by Sen. Pray of Penobscot, Rep. Paradis of Old Town, and Rep. Rolde of York. Human Resources Hearing 02/24/88. Majority OTP-AM Accepted 04/18/88 (Minority ONTP). Pursuant to Joint Order SP 1004, this Bill was recalled from Engrossing. Amended by: SA S-491. Enacted, Approved 05/02/88, PUBLIC LAWS, Chapter 835.
