Foster of Ellsworth, and Sen. Clark of Cumberland. Appropriations & Financial Affairs Hearing 02/25/88. OTP-AM Accepted 04/12/88. Amended by: CA H-662. Enacted, Veto Sustained.

Joint Order, That Bill, "An Act to Establish Child Care Availability for Individuals in the Substance Abuse Treatment System," HP 1612, LD 2205, and all its accompanying papers, be recalled from the Governor's desk to the Senate. Presented by Sen. Bustin of Kennebec. Passed in Senate; Indefinitely Postponed in House. In Senate - Insisted; In House - Insisted. Died Between Houses.
