LD 2538 / HP1855

AN ACT to Recodify the Laws on Municipalities and Counties. (Reported Pursuant to a Study by the Committee on State and Local Government). Engrossed Without Reference. Enacted. Pursuant to Joint Order HP 1890, this Bill was Recalled from the Governor's Desk. Amended by: HB H-714, HC H-715, SA/HC S-474. Enacted, Approved 04/19/88, PUBLIC LAWS, Chapter 737.

Joint Order, That HP 1855, LD 2538, Bill, "An Act to Recodify the Laws on Municipalities and Counties" and all its accompanying papers be recalled from the Governor's desk to the House. Presented by Rep. Carroll of Gray. Passed in Concurrence, 03/24/88.
