An Act to Amend the Maine Income Tax Laws. Presented by Rep. Mayo of Thomaston; Co-sponsored by Rep. Cashman of Old Town, Rep. Nadeau of Saco, and Sen. Andrews of Cumberland. Taxation Hearing 03/21/89. Majority OTP-AM Accepted 06/22/89 (Minority OTP-AM). Amended by: CA H-674, SA/CA S-394. Enacted, Approved 06/29/89, PUBLIC LAWS, Chapter 495.
