An Act to Annex Township 4, Range 3 WELS to the Town of Island Falls. Presented by Rep. Smith of Island Falls; Co-sponsored by Sen. Pearson of Penobscot, and Rep. Martin of Eagle Lake. State & Local Government Hearing 03/08/89. Recommitted to State & Local Government in the House; Majority ONTP Accepted in Senate. House - Accepted Minority OTP Report and Engrossed as Amended by HA H-915; Senate - Adhered to Majority ONTP Report. Final Disposition: Died Between Houses.
