An Act to Create the Individual Income Tax Windfall Fund. Presented by Sen. Andrews of Cumberland; Co-sponsored by Rep. Cashman of Old Town, Sen. Pray of Penobscot, and Rep. Martin of Eagle Lake. Taxation Hearing 04/20/89. Majority OTP-AM Accepted 05/25/89 (Minority ONTP). Amended by: CA S-128, HA/CA H-369. Emergency Enactment Failed.
