An Act Concerning Compensation for Sunday Employment. Presented by Rep. McHenry of Madawaska: Co-sponsored by Rep. Clark of Millinocket, and Rep. Rand of Portland. Labor Hearing 05/24/89. Majority OTP-AM Accepted by House; Minority ONTP Accepted by Senate. House - Insist on Engrossment with CA: Senate - Insist on Minority ONTP. Died Between Houses.
