Resolve, Concerning the Development of a New Master Plan for the Capitol Area. Presented by Rep. Martin of Eagle Lake; Co-sponsored by Sen. Pray of Penobscot, Rep. Webster of Cape Elizabeth, and Sen. Cahill of Sagadahoc. State and Local Government Hearing 06/05/89. OTP-AM Accepted 06/16/89. Amended by: CA H-551, SA/CA S-433. Emergency Finally Passed. Neither Signed nor Vetoed by the Governor. Pursuant to Joint Order SP 670, this Bill was Recalled from the Governor's Desk. Amended by: CA H-551, SD/CA S-465. Emergency Finally Passed, Approved 08/23/89, RESOLVE LAWS, Chapter 60.
