LD 1695 / HP1223

An Act to Authorize Department of Transportation Bond Issues in the Amount of \$21,000,000 to Match Available Federal Funds for Highway, State and Local Bridges, Harbor and Airport Improvements. Presented by Rep. McPherson of Eliot; Co-sponsored by Sen. Gould of Waldo, Rep. Macomber of South Portland, and Sen. Twitchell of Oxford. Transportation Hearing 05/31/89. OTP-AM Accepted 06/13/89. Amended by: CA H-493. Enacted, Approved 07/10/89, P & S LAWS, Chapter 72. Approved in Referendum, 11/07/89 (In favor: 152,148; Opposed: 82,548).
