LD 1702 / SP0608

Original Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$49,500,000 for Construction and Renovation of Correctional Facilities. Amended by: CA (Changed Title) S-332. House - Indefinitely Postponed; Senate - Recommended to Corrections (Joint Select). Committee of Conference Report - Unable to Agree. Died Between Houses 07/01/89.
