LD 1727 / HP1235

An Act to Authorize a General Fund Bond Issue in the Amount of \$19,110,600 for the Maine Vocational-Technical Institute System. Presented by Rep. Gwadosky of Fairfield; Co-sponsored by Rep. Lisnik of Presque Isle, Rep. Carter of Winslow, and Sen. Perkins of Hancock. Appropriations & Financial Affairs Hearing 06/12/89. OTP-AM Accepted 06/19/89. Amended by: CA H-616. Enacted, Approved 07/12/89, P & S LAWS, Chapter 85. Approved (as amended by P & S LAWS, Chapter 92) in Referendum, 11/07/89 (In favor: 139,124; Opposed: 95,154).
