LD 1755 / HP1258

An Act to Authorize Cumberland County to Raise up to \$25,000,000 for Construction of a New Jail Facility for Cumberland County. Presented by Rep. Manning of Portland; Co-sponsored by Rep. Strout of Windham, Rep. Anthony of South Portland, and Rep. Carroll of Gray. State and Local Government. Majority OTP-AM Accepted 06/20/89 (Minority OTP-AM). Amended by: CA H-628. Enacted, Approved 06/28/89, P & S LAWS, Chapter 63.
