An Act to Repeal the Homestead Exemption. Presented by Sen. Andrews of Cumberland; Co-sponsored by Rep. Cashman of Old Town, and Rep. Martin of Eagle Lake. Taxation Hearing 01/23/90. Majority OTP Accepted 03/22/90 (Minority ONTP). Amended by: HA H-988. Final Disposition: Enacted, Veto Sustained.
