LD 2305 / HP1665

An Act Allowing the Yarmouth Water District to Acquire the Assets and Liabilities of the North Yarmouth Water District. Presented by Rep. Foss of Yarmouth; Co-sponsored by Sen. Dillenback of Cumberland, Sen. Clark of Cumberland, and Rep. Butland of Cumberland. Utilities Hearing 02/26/90. OTP Accepted 03/02/90. Emergency Enacted. Pursuant to Joint Order SP 968, this Bill was Recalled from the Governor's Desk. Amended by: SA S-585. Final Disposition: Emergency Enacted, Approved 04/06/90, P & S LAWS, Chapter 111.

Joint Order, That Bill "An Act Allowing the Yarmouth Water District to Acquire the Assets and Liabilities of the North Yarmouth Water District," HP 1665, LD 2305, be recalled from the Governor's desk to the Senate. Presented by Senator DILLENBACK of Cumberland. Final Disposition: Passed in Concurrence, 03/15/90.
