LD 2363 / HP1712

An Act to Amend the Solid Waste Landfill Remediation and Closure Laws Administered by the Department of Environmental Protection. Presented by Rep. Foss of Yarmouth; Co-sponsored by Rep. Michaud of East Millinocket, and Rep. Larrivee of Gorham. Energy & Natural Resources. House - Adhered to Re-refer to Judiciary; Senate - Adhered to Re-refer to Legal Affairs. Died Between Houses. Pursuant to Joint Order HP 1789, this Bill was Recalled from the Legislative Files. Energy & Natural Resources Re-referred to Legal Affairs Hearing 03/05/90. OTP-AM Accepted 04/05/90. Amended by: CA H-1075, HA/CA H-1092. Final Disposition: Emergency Enacted, Approved 04/19/90, PUBLIC LAWS, Chapter 870.
