An Act to Provide Tax Amnesty and Necessary Administrative Support to the Bureau of Taxation. Presented by Rep. Whitcomb of Waldo; Co-sponsored by Sen. Emerson of Penobscot, and Rep. Hepburn of Skowhegan. Taxation Hearing 03/13/90. Majority OTP-AM Accepted 04/06/90 (Minority ONTP). Amended by: CA H-1093, SB/CA S-692.
