LD 2436 / SP0969

An Act to Authorize Franklin County to Acquire a Parcel of Land in Coburn Gore.
Presented by Sen. Webster of Franklin; Co-sponsored by Rep. Dexter of Kingfield. Energy & Natural Resources Re-referred to Legal Affairs Hearing 03/28/90. Majority OTP-AM Accepted 04/05/90 (Minority ONTP). Amended by: CA S-653. Adhered to Failed Emergency Enactment in House. Engrossed as Amended by CA S-653 and SA S-671 in the Senate. Final Disposition: Died Between Houses.
