LD 2446 / HP1779

Resolve, Authorizing the Conveyance of Certain Public Lands and the Settlement of a Boundary Line Dispute Involving Public Lands. Presented by Rep. Gould of Greenville; Co-sponsored by Sen. Pray of Penobscot, Rep. Jacques of Waterville, and Rep. Merrill of Dover-Foxcroft. Energy & Natural Resources Hearing 03/28/90. House - Adhered to Majority OTP-AM; Senate - Adhered to Minority OTP-AM. Died Between Houses. Pursuant to Joint Order SP 1008, this Bill was Recalled from the Legislative Files. Amended by: HB H-1135. Final Disposition: Finally Passed, Approved 04/24/90, RESOLVE LAWS, Chapter 97.
