Joint Order, that the Joint Select Committee on Corrections report out a bill to provide for a General Fund bond issue for prison construction and any other necessary legislation to implement a long-term correctional policy for the State. Presented by Representative MELENDY of Rockland. Final Disposition: Passed in Concurrence, 01/03/90. (See LD 2469, LD 2470, LD 2471)

(Reported Pursuant to Joint Order HP 1483; Majority Report). OTP Accepted 04/05/90. Amended by: SA S-661. Enacted, Approved 04/20/90, P & S LAWS, Chapter 133. Final Disposition: Failed in Referendum, 11/06/90 (In favor: 187,622; Opposed: 306,887).
