An Act to Reduce Costs to County and Municipal Government by Delaying the Implementation Dates of Certain State Mandates. Presented by Sen. Cahill of Sagadahoc; Co-sponsored by Rep. Reed of Falmouth, Sen. Ludwig of Aroostook, and Rep. Small of Bath. State & Local Re-referred to Energy & Natural Resources. Majority OTP-AM Accepted 04/12/90 (Minority ONTP). Final Disposition: Enacted, Approved 04/24/90, PUBLIC LAWS, Chapter 926.
