An Act to Amend the Severance Pay Laws. Presented by Sen. Pray of Penobscot; Co-sponsored by Rep. Heeschen of Wilton, Rep. Pineau of Jay, and Rep. Clark of Millinocket. Labor Hearing 01/31/91. Majority OTP-AM Accepted 05/22/91 (Minority ONTP). Amended by: CA S-159. Enacted. Final Disposition: Veto Sustained 06/26/91.
