Resolve, to Establish the Commission to Study the Use of Professional Strikebreakers. Presented by Rep. McHenry of Madawaska. Labor Hearing 04/02/91. OTP-AM Accepted 05/06/91. Amended by: CA H-185, SA S-421. This Bill died on adjournment July 10, 1991. Pursuant to Joint Order HP 1395, this Bill was recalled from the legislative files. Final Disposition: Emergency Finally Passed, Unsigned 12/31/91, RESOLVE LAWS, Chapter 53.
