An Act to Amend the Provisions Regarding the Uniform Traffic Ticket and Complaint. Presented by Sen. Holloway of Lincoln. Judiciary Hearing 02/21/91. OTP-AM Accepted 04/17/91. Amended by: CA S-54. Died on Adjournment July 10, 1991. Pursuant to Joint Order SP 781, this Bill was Recalled from the Legislative Files. Final Disposition: Enacted, Approved 07/26/91, PUBLIC LAWS, Chapter 593.
