An Act to Revise the Small Claims Laws. Presented by Sen. Gauvreau of Androscoggin. Judiciary Hearing 02/21/91. OTP-AM Accepted 06/05/91. Amended by: CA S-238, SA/CA S-427. Died on Adjournment July 10, 1991, Pursuant to Joint Order HP 1395, this bill was recalled from the legislative files. Final Disposition: Emergency Enacted, Approved 07/30/91, PUBLIC LAWS, Chapter 604.
