Joint Order, Directing the Joint Standing Committee on Appropriations and Financial Affairs to meet as an investigating committee to thoroughly study the anticipated revenues and incomes of State Government and all of its departments, agencies, authorities, bureaus, offices or other bodies or officials, from any sources and all presented appropriated or anticipated expenditures, and to report to the Legislature its findings, together with any proposals and proposed legislation. Presented by Speaker MARTIN of Eagle Lake. Final Disposition: Passed in Concurrence 12/21/90. (See LD 274, LD 275, LD 1882, LD 1951, LD 1961, LD 1973, LD 1984)
