An Act to Promote the Emotional Health of Children During Periods of Stress. Presented by Rep. Anthony of South Portland; Co-sponsored by Rep. Dore of Auburn, Rep. Stevens of Bangor, and Rep. Richards of Hampden. Judiciary Hearing 03/01/91. Majority OTP-AM Accepted 06/10/91. Amended by CA H-407. House - Insisted on Engrossed as Amended by CA; Senate - Adhered to Indefinite Postponement. Final Disposition: Died Between Houses 06/12/91.
