An Act to Establish the State of Maine Credit Card. Presented by Rep. Hoglund of Portland; Co-sponsored by Rep. Dore of Auburn, Rep. Wentworth of Arundel, and Rep. Rand of Portland. Banking & Insurance Hearing 02/21/91. Majority OTP-AM Accepted by House; Minority ONTP Accepted by Senate. House - Insisted on Engrossed as Amend by CA H-197; Senate - Adhered to Minority ONTP. Final Disposition: Died Between Houses 05/09/91.
