History and Final Disposition

LD 349 / HP0258

An Act to Protect the Public from Unsafe Industrial and Commercial Facilities. Presented by Rep. McHenry of Madawaska; Co-sponsored by Rep. Joseph of Waterville, Sen. Mills of Oxford, and Rep. Pineau of Jay. Labor Hearing 03/27/91. Majority OTP-AM Accepted 06/11/91 (Minority ONTP). Amended by: CA H-590, SA/CA S-428. Died on Adjournment 07/10/91. Pursuant to Joint Order HP 1395, this Bill was Recalled from the Legislative Files. Enacted. Vetoed 01/07/92. Final Disposition: Veto Sustained 01/07/92.
